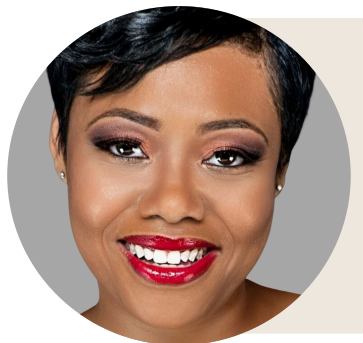
Katie Harbison

The youngest African American woman ever elected to the Tennessee Senate—and the first to give birth while in office—she has been a leading voice for maternal health, family well-being, and economic opportunity. She has sponsored more than 45 bills advancing healthcare access, job creation, voting rights, and efforts to eliminate human trafficking.

Patrick Lanne is a Partner at Public Opinion Strategies, serving as lead pollster for numerous Republican officials nationwide, including members of Congress, governors, and a U.S. Senator. His research spans issues such as early education, economic development, health care, and public policy.
